Friends,

Jesus had many run-ins with the Pharisees and other religious leaders. They argued with Jesus. They spoke to crowds about how much they disagreed with Him. They made accusations against Him.

But sometimes it was what the Pharisees DIDN'T say that meant the most. In their encounters with Jesus, these religious leaders were often struck silent. Sometimes Jesus asked them questions that they simply couldn't answer because what He said or did went against their own self-righteous legalism. And then they would find their positions indefensible. Like one time when Jesus wanted to heal a man on the sabbath, which the Pharisees insisted was against God's law...

Then Jesus said to them, 'Is it lawful to do good or to do harm on the sabbath, to save life or to kill?' But they were silent. He looked around at them with anger; He was grieved at their hardness of heart...

from Mark 3:4-5

Other times, when the Pharisees argued with Jesus in public, Jesus would give them a choice of how they could answer a question. Then they would realize that neither answer would make them look good. This made it painfully obvious that the Pharisees were often less worried about what God wanted than they were about their own image in the public eye.

Jesus answered them, 'I will also ask you a question, and you tell me: Did the baptism of John [the Baptist] come from heaven, or was it of human origin?' They discussed it with one another, saying, 'If we say, "From heaven", He will say, "Why did you not believe him?" But if we say, "Of human origin", all the people will stone us; for they are convinced that John was a prophet.' 'So they answered that they did not know where it came from.

Luke 20:3-7

Politicians, like Pharisees, talk a lot. They deliver speeches and do interviews. They make promises about what they plan to accomplish. They make accusations against their opponents. But sometimes it's more meaningful to listen to their silences; to what they DON'T say. When someone asks them a question they don't want to answer, do they change the subject to their favorite talking points? When they deliver a stump speech, are there issues they choose not to talk about?

This November 5th, we have the opportunity to fulfill our duty as Americans to vote (you ARE going to vote, right?). You can vote for your favorite politicians or vote against the ones you don't like. But as you prepare and pray beforehand (you DO pray before you vote, right?), don't just focus on what politicians have said. Consider the issues on which a politician has decided to remain silent. The questions they didn't answer. The subjects they glossed over. And then ask yourself. Are you voting for a politician? Or for a Pharisee?

No one was able to give him an answer, nor from that day did anyone dare to ask him any more questions.
